That leaves a few options, there was a plan for Lantern Ridge to create a loop, Acre 39, or Lorraine Dr. As far as I'm concerned, we are the only ones who are thinking of something. I want to dive deeper into this. **JD** I have thoughts on another location with that kind of money is Matthies Park. I went on the Hayride and there's a trail there which is in bad need of maintenance. **JT** But Matthies Park is Park & Rec. **LPB** Someone told me this commission could not maintain it years ago, so Park and Rec took it on. After the tornado I think there was a lot of work needed and damage. I would highly encourage everyone to look on the website. I would likely say there will be many applications. I would think something like this would be a series of votes. **JT** I think step one is identify what would we like to do. **LW** How about Naugatuck Greenway? **LPB** I believe there is already a plan for that. *\*Discussion Followed about Greenways and multiple locations\** **LPB** So we should circle back to identify. **JT** I think individually come up with some ideas and throw them all together. **LW** I like the idea of connecting trails or to Naugatuck State Forest. **JT** If we do Lantern Ridge there's an area we can expand for parking. **LW** Could we build another trail head from Lantern Ridge on 42? **VS** At the end of Hockanum Glen there's an opening to a trail that will take you to Lantern Ridge. **JT** I see it now. (Referencing maps) **LPB** We had years ago people come and present years ago and they talked about Statewide Goals on Land Conservation – I think with this grant those are important things to tape into... I think the broader reach we have the more points we can get and this goes in HVA watershed. **VS** That could be someone we could bring in to help us how to word this for the grant. **LPB** So our to-dos are to get and share ideas what to use the money for.
